0.5 It is not necessary to apply the whole of Chapter A of Appendix 10 each time a wagon is sent to a workshop, only those provisions relating to the damage that is to be repaired. Irrespective of the reason for a wagon's withdrawal from service, compliance with those provisions of module M00.002\* that are marked with an asterisk (\*)-is required systematically whenever a wagon is sent to the workshop.
